

# Health Insurance for Pregnant Women



## BadgerCare Plus


Are you pregnant?

Do you need health insurance or a better plan?



- BadgerCare Plus pays for the baby's delivery and health care while you are pregnant.
- For the mom, this health insurance lasts 60 days after the baby is born.



 What if I already have health insurance?

**You may still qualify** based on your household's income



**1.** You may qualify for BadgerCare Plus if:

☐ You are pregnant



☐ Your household's salary or income is equal or lower than:

Income before taxes	Household size

Count each unborn baby in family size

**Example:**



**Household size: 3**

**Family:** 2 married adults, and 1 baby on the way

**Income:** \$5,600 or less a month


**Mom qualifies**

## Immigrant?

**Lawfully present immigrants** - You can get BadgerCare Plus if you are pregnant.

**Undocumented Immigrants**  
You may qualify for BadgerCare Plus Prenatal Services.

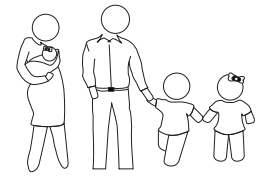

# After your baby is born:

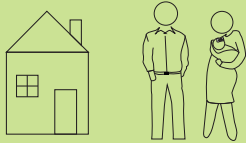
## Get BadgerCare Plus for baby and see if other family members qualify

1. Call **1-800-362-3002**, ask for your county agency phone number. Tell the county agency the baby was born.
2. Say you need BadgerCare Plus for the newborn and any other children in your household.
3. Ask if the adults in your household will qualify.



**Adults and children qualify for BadgerCare Plus at different income levels.** To see who qualifies, find your total household size and read the chart across.

### Example:



**Household size: 3**  
**Income: \$1,830/month**  
**Adults and child qualify**

household size	Man	Woman	Pregnant Woman	Child (under age 19)

## Marketplace Health Insurance (Obamacare)

If anyone in your family does not qualify for BadgerCare Plus, they might qualify for financial help from the Marketplace.

1. Check the chart to see if you will get financial help from the Marketplace.
2. Sign up during Open Enrollment

**November 1st-December 15th**

**Household - who you file taxes with**

### Sign up within 60 days of some life changes:

#### ■ Loss of coverage

Loss of insurance from a job, Cobra, BadgerCare Plus, student or parent's plan

#### ■ Moving

A permanent move to a new county

#### ■ Changes in household size

Birth or adoption, marriage, divorce, legal separation, death

#### ■ Immigration

Got citizenship or lawful presence in the U.S.

#### ■ Release from incarceration or jail

#### ■ Tribal Membership

Members of a federally recognized tribe may enroll at any time

**⚠ If you can't get insurance, call 2-1-1 and ask for a free clinic or community health center near you.**
